Location

Forming part of an established industrial estate located off Oliver Road, approx. 1.5 miles South of junction 30/31 of the M25. Chafford Hundred Train Station is approx. 2.5 miles distant, providing a service to London (Fenchurch Street) in approx. 33 minutes. Lakeside Shopping Centre is situated approx. 1.5 miles distant.

The Property

Three inter-linking units totaling 21,192 sq ft (1,969.6 sq m). The main unit has an eaves height of 7.75 m and apex height of 11.5m. A loading door in the front elevation and two in the side provide access.

The elevations are fully clad beneath a pitched lined roof. There is no mains water, nor toilets to the unit. The smaller units have eaves heights ranging between 6.3 and 8.3m.

Good quality detached two storey modular offices are located to the front with modular works toilets behind.

Externally, there is a substantial fenced, gated and fully concreted yard.

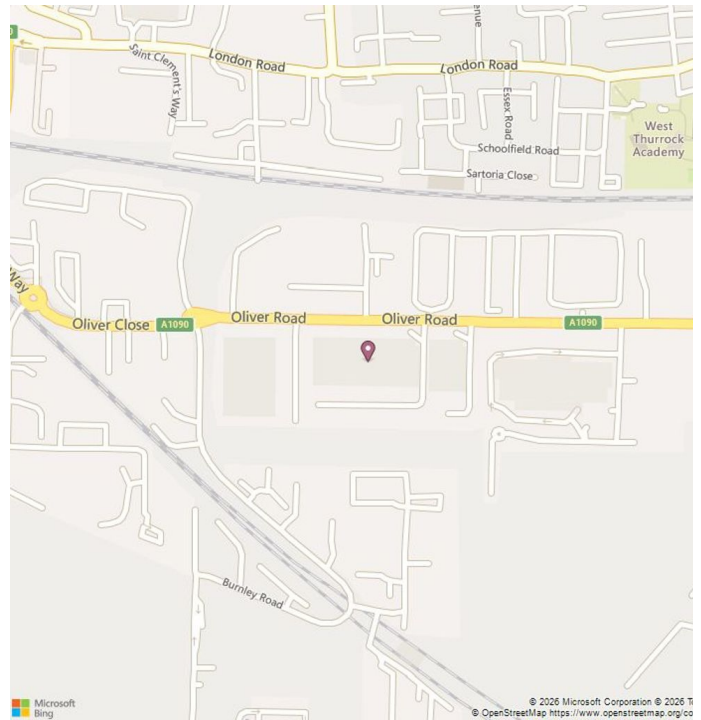
